## 1. Welcome and Apologies

Alistair Dodds (Highland Council), Alex Paterson (HIE)

#### 2. Previous Minutes

Agreed with one amendment (comment attributed to NL, page 1, final paragraph) and one addition (AP suggestion re MTRC programme, page 3, 2<sup>nd</sup> paragraph).

## 3. Matters Arising

Updates on previous actions:

- Meeting of tourism staff still under discussion. HIE will produce paper for next meeting. **ACTION (1) RK**
- NHI presentation will be at the March 2013 EB meeting.
- Chairman wrote to HMRC and received holding response. Cllr Drew Hendry wrote and has yet to receive a response. Highland Council offer of office space to enable ongoing HMRC presence was made during initial responses in 2008/09.
- Joint Executive and Advisory Board meeting is planned for June 2013.
- Communications ES has been working with DSRL to produce a 'This Is Caithness' insert for local press. Discussion that this could also be targeted to a wider audience.

# 4. Issues from CNSRP Advisory Board, 30<sup>th</sup> November 2012

Main discussions were around skills development. It was agreed that sector-based skills "academies" (such as the one established at Nigg with Global Energy) offered a useful model to support both existing company growth and inward investment, particularly with the excellent support infrastructure available in Caithness. ES outlined ongoing discussions between SDS, Job Centre Plus, Highland Council, North Highland College and Caithness Chamber on this issue.

It was agreed that "talent attraction" should appear in the updated CNS inward investment marketing plan currently being revised. ACTION (2) RK

AS agreed that SDS would coordinate the development of a skills development programme to support both existing company growth and inward investment in the north. **ACTION (3) AS**.

AS will also provide update at next meeting on a Regional Skills Investment Plan being developed jointly by HIE and SDS. **ACTION (4) AS** 

### 5. Inward Investment Update

RK outlined progress, with recent inward investments such as Natural Retreats, Wolfburn Distillery and the Thurso Cinema. A number of existing investors are considering further investment. RK said that during 2013 there could be investments in the area by companies engaged in marine and offshore renewable energy development. However, these investments will be dependent upon the outcome of applications to Marine Scotland for consent.

Scrabster Harbour Trust's phase 1 development will be complete shortly. Progress with the development of the site designated as an Enterprise Area was discussed. **ACTION (5) ES** to send a letter to Scrabster Harbour Trust (SHT) offering assistance to help progress the Enterprise Area and inviting a representative from SHT to an Executive Board meeting.

#### **Comments**

- SB said that SCDI used to hold dinners in London with investors, and that this would be worth discussing. **ACTION** (6) SB to pass SCDI details to RK.
- Journalists (freelance, trade press and national press) can be attracted to the area to write articles on specific topics relevant to the Partnership's key priorities. **ACTION** (7) **ALL** pass any contacts to RK.
- HIE are discussing improvements to the "Caithness Ambassadors" project. **ACTION (8) ES** circulate list of current members with a view to receiving further suggestions for ambassadors.
- The Caithness & North Sutherland Inward Investment Marketing Plan is being revised, and this will also indicate relevant events and conferences that could be held in the area (such as the recent UHI Peatlands conference). ACTION (9) SB to pass on contact for Moira Unwin, VisitScotland, regarding conference funding. ACTION (10) All send conference topic ideas to RK.
- **ACTION (11) ES** Approach key companies re potential for area profile raising via well-known guests.

### 6. Programme Manager Update

### - Project Level Priorities Update

- The EB agreed that an initial 5 priority projects would be identified for joint support over the coming year. **ACTION** (12) **ES** to circulate list of projects including summary description. The projects to be led and coordinated at Delivery Group, with quarterly reporting of progress to Executive Board. ES will also manage a pipeline of other projects to ensure awareness of ongoing development opportunities.
- ACTION (13) HIE & NDA meet to discuss short-term funding requirement for Wick Harbour Authority and agree a project lead –

reporting back at next meeting. RH also confirmed that Babcock had offered WHA support with project management.

## - Communications update.

- The CNSRP Communications Plan will be refreshed in January 2013 with key messages for 2013/2014. ACTION (14) ES to build 12 month rolling programme of communications. ACTION (15) All to alert ES to upcoming press opportunities.
- o A CNSRP 2012/13 summary report will be prepared. **ACTION (16) ES** to circulate a draft when prepared

### 7. Any other business

The Chairman welcomed NDA's announcement that the National Nuclear Archive project (including the North Highland Archive) will proceed to the next phase of work. Current NDA plans indicate that a commercial partner for the project will be appointed by mid-2013 and the facility will be operational in early 2016.
